2665-2719 In exercise of powers conferred by Section No.SOR-II (1)24/2016-S&GAD 25 of the Balochistan Civil Servants Act, 1974, (Act No. IX of 1974) the Government of Balochistan is pleased to make the following rules regulating the recruitment to the Balochistan Agriculture Department (Research Wing) Subordinate Ministerial Service (BPS-1 to 15) Service, and prescribing conditions of service for the persons appointed thereto, namely:-

> > Service Rules No. XXIV of 2016.

PART-I-GENERAL

- Short title and commencement: (1) These rules may be called "the Balochistan Agriculture Department (Research Wing) Subordinate Ministerial Service (BPS-1 to 15) Service Rules, 2016".
 - (2) They shall come into force at once.
- Definitions: (1) In these rules, unless there is anything repugnant in the subject or context,-

- a) "Act" means the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974);
 - b) "Appendix" means the Appendix nexed to these rules;
 - c) "Appointing Authority" means the appointing authority as specified in rule 4
 - d) "Board" means a Board of Intermediate and Secondary Education established by law in Pakistan or any other educational authority or institution declared by Government in consultation with Commission to be a Board for the purpose of these rules;
 - e) "Basic Pay Scales (BPS)" means the Basic Pay Scale of a post specified in column 2 of the Appendix and such other post in the Service as may b specified by the Government from time to time for the purpose of these rules;
 - f) "Commission" means the Balochistan Fublic Service Commission;
 - g "Department" means the Balochistan Agriculture and Cooperative
 - "Government" means the Government of Balochistan;

- i) "Initial recruitment" means appointment made otherwise than by or transfer from another Service/Department/Post;
- j) "Post" means a post specified in column 2 of the Appendix and such oth post in the Service as may be specified by the Government from time to time for the purpose of these rules;
- k) "Recognized Institute" means any institute established by law in Pakistan or any other Institute declared by the Government in consultation with the Commission to be a recognized Institute for the purpose of these rules;
- 1) "Recognized University" means any University established by aw in Pakistan or any other University declared by the Government in consultation with the Commission to be a recognized University for the purpose of these rules;
- m) "Rules" means the Balochistan Agriculture Department (Research Wing) Subordinate Ministerial Service (HPS-1 to 15) Service Rules, 2016;
- n) "Service" means the Balochistan Agriculture Department (Research Wing) Subordinate Ministerial Service (BPS-1 to 15) Service; and
- o) "Selection/Promotion Committee" means the Selection/Promotion Committees constituted by the Department under the rule 5 of the Balochistan Civil Servants (Appointment, Promotion and Transfer) Rules, 2009.
- (2) Words and expressions used by not defined herein above sub-rule (1), unless the context otherwise requires, shall have the same meanings as assigned to them in the Act.

PART-II-RECRUITMENT

- 3. <u>Eligibility and Composition of the Service</u>. (1). No person who is married to a foreign national shall be eligible for appointment to the Service.
- (2) The restriction imposed hereinabove sub-rule (1), may be relaxed by Government in case of a person who is married or proposed to marry a foreign national of any country recognized by the Government of Pakistan.
- (3) The Service shall comprise of the posts as specified in column 2 of the Appendix and such other posts as may be determined by Government from time to time.
- 4. <u>Appointing Authority</u>. Appointment to the posts in the Service shall be made by the appointing authority as specified in rule 4 of the Balochistan Civil Servant: (Appointment, Promotion and Transfer) Rules, 2009.
- 5. <u>Method of Recruitment</u>. (1) The appointment to the posts and Basic Pay Scale of the post in the Service shall be as specified in column 4 of the Appendix.
- (2) All the posts for initial recruitment shall be filled from amongst the candidate domiciled/local of Balochistan.
- 6. Age. No person, who is less than 18 years or more than 28 years of age shall t appointed to the Service by initial recruitment:

Provided that only the upper age limit may be relaxed in terms of rules 3 and 4 c Balochistan Government Initial Appointment to Civil Service Posts (Age and Relaxation Upper Age Limit), Rules, 2012.

- 7. Qualification.— (1) No person shall be appointed to a post and Basic Scale in Service by Initial recruitment, unless he possesses the qualifications prescribe the post in column 3 of the Appendix.
- Service unless he produces a certificate of character from the Principal/Academic Office the academic institution last attended and also certificates of character from two or responsible persons/gazetted officers not being his relatives and who are well acquain with his character and antecedents.
- (3) No person shall be appointed by initial recruitment to the Service unless had declared to be physically fit by the Medical Board constituted by the Government for purpose or a Government Medical Officer not below the rank of District Health Officer the case may be.

PART-III-CONDITIONS OF SERVICE

- 8. <u>Probation.</u>— A person appointed to a post in the Service on regular basis stremain on probation for a period as prescribed in rule 2-A of the Balochistan Civil Serva (Confirmation) Rules, 2012.
- 9. <u>Confirmation.</u>— After satisfactory completion of the probationary period, a c servant appointed on probation under rule 8, provided that he holds a substantive poshall be eligible for confirmation in service or a post or a Basic Pay Scale as prescribed rule 20 of the Balochistan Civil Servants (Appointment, Promotion and Transfer) Rule 2009 and in rule 3 of the Balochistan Civil Servants (Confirmation) Rules, 2012.
- 10. <u>Seniority</u>.— (1) The inter se seniority of the members of the Service appointed the posts in the same Basic Pay Scale shall be determined as prescribed in rule 21 of the Balochistan Civil Servants (Appointment, Promotion and Transfer) Rules, 2009 and in the Balochistan Civil Servants (Seniority) Rules, 2008.
- 11. <u>Liability to Transfer and Serve.</u> The members of the Service shall be liab
 - (a) transfer anywhere in Balochistan; and
 - (b) to serve in any department of Government or any local authority of statutory body setup of established by Government:

Provided that where a member of the Service is required to serve in a post outside his Service or cadre, his terms and conditions of service as to his pay shall not be less favourable than those to which he would have been entitled, if he has not been so required to serve.

- General Rules. In all matters not expressly provided for in these of the Service shall be governed by such rules as have been or may hereafter by the Government and made applicable to them.
- Any provision of these rules, for reasons to be recorded Relaxation.writing, may be relaxed in individual cases if Government is satisfied that a application of the rules would cause undue hardship to the individual concerned:

Provided that wherever such relaxation involves a question on which cor matie with the Commission is mandatory, the Commission shall be consulted before t relaxation is made.

- 14. Delegation.-The Government may delegate all or any of its powers und these rules, to any officer subordinate to it.
- 15. The Balochistan Agriculture Department Ministerial (Research Wi (BPS-1 to 15) Service Rules, 1984, are hereby repealed.
